**PRINCETON CONSERVATION COMMISSION**  
**MINUTES FOR MEETING**  
**February 21, 2017**

**PRESENT:**

Ron Thompson, Brian Keevan, Rachael Catlow, John Vieira and Susan Mitchell from the PCC were in attendance. As well as Brett Trowbridge associate member.

Brian Keevan called the meeting to order at 7:03 pm.

**OLD BUSINESS:**

- Mohamed Samoda attended the PCC meeting regarding a site visit done on January 4, 2017 with Brian Keevan and John Vieira at 77 Main Street, Princeton owned by Mohamed Samoda. An Enforcement Action was issued on January 5, 2017 for an underground propane tank installed without the filing of a Notice of intent. PCC members voted to ratify the Enforcement Action. PCC requested a Notice of Intent be filed as well as installation of erosion controls. Mr. Samoda stated that the installing company was responsible for getting all permits for the job. Lorden Oil Co. in Ayer was the installing company. John Vieira and Brian Keevan both spoke to Doug from Lorden Oil Co. An email was also sent to Lorden Oil Co. DCR issued a determination that it's under The Watershed Protection Act, and it is exempt as reconstruction structural change extension. NOI is expected at the March meeting.
- The clean- up at Fieldstone farm has not been started nothing has been removed from the wetlands yet. Also the septic system installation has not begun. Discussed who is the responsible party; PCC would like a letter stating that.
- Brian Keevan and Brett Trowbridge attended a Trail Meeting about Fieldstone Farm trails. The need for the use of machinery to do the work doesn't seem needed for a trail for human passage.
- Discussion regarding the clean- up of the Town Pound, Brian meet with Joe Lee in December about getting a clean-up crew to make it accessible to the public. Brian will attend the next Historical Society Meeting to discuss with them this possibility.
- David Caporello resigned from the Conservation Commission after the January Board of Selectmen meeting.
