- CG, CS and CBH attended. EAC hosted table with draft Environmental Action Plan (EAP) for review, question, and comment. There was minimal traffic at EAC table. Those who stopped by at table were interested and supportive.

EAP Next Steps

- If moving forward on Green Communities designation—dependent on Selectboard feedback— EAC will need to provide regular information sharing to town residents, particularly with regard to three related bylaws that would need Town Meeting vote
 - CG suggests getting information from other towns—such as Rutland—as to how they were successful in becoming a designated Green Community

Comments to Date (on draft EAP)

- Comments received to date on EAP are mostly supportive with some feedback on additional sub-topics. For example, Charlie Cary has offered a perspective on using locally available wood heat, and Richard Chase has suggested pursuit of Green Communities designation.

- ACTION: CG and CS to draft press releases for Town News and The Landmark and Redemption Rock News—providing link to draft EAP for resident review and information regarding public forum date, time, and location

 - o ACTION: CS to create list of information topics for public communications schedule
