DO YOU QUALIFY FOR THE **SENIOR** **CIRCUIT BREAKER** 2022 TAX CREDIT?

If you are a homeowner, your MA property tax payments, together with half of your water and sewer expense, must exceed 10% of your total Massachusetts income for the tax year. If you are a renter, 25% of your annual MA rent must exceed 10% of your total MA income for the tax year.

For tax year 2022, the maximum credit amount is \$1,200. To be eligible:

- > You **MUST** be a Massachusetts resident or part-year resident
- > You **MUST** be 65 or older by December 31, 2022
- > You **MUST** own or rent residential property in MA and occupy it as your primary residence
- > Your MA Income **CAN'T EXCEED** \$64,000 for single person, \$80,000 for head of household, or \$96,000 for married, filing jointly.
